STARLITES PAST (CONTINUED)

25 Years Ago Fall Starlite 1987

"The Society has been notified that it has been awarded a grant of \$300 from the Peoria Area Arts and Sciences Council (PAASC)..../The money granted will be used, along with society funds, to purchase a Farquhar Celestial Globe and a Sun-Earth-Moon model."

Keeping up with the new technology has always been a goal of the board. The recent purchase of digital sidereal clock is one example. We still have some money left over from our fund-drive for the Northmoor restoration. Any one with a purchase suggestion should contact any board member.

"This fall, we will begin a telescope loan program for our members. Two telescopes will be used--a 3-inch Unitrom donaed by Betty Ohl, and an 8-inch Dobsonian. Details of this program will be found in this issue and the telescopes will be on display at the annual banquet."

It is sad to say that program no longer exists, at least not formally. One telescope that was used as part of a successor program has been 'missing' for years now. The board is contemplating officially restarting this program. A volunteer to monitor it would be helpful.

BY-LAWS REVIEW AND CHANGES

The Board of Directors initiated a project in 2011 to review and update the PAS By-Laws. Rather than trying to review the By-Laws in their entirety, the review committee decided to break the work into smaller, more manageable packages. Proposed amendments to each package could then be independently brought before the Board for approval. Once approved by the Board, each package requires approval by the general membership. This approach allows the review to take place over a longer period of time and allows for membership approval to occur over multiple Society meetings.

The next package was submitted to and approved by the Board. You will be asked to approve these changes via vote during the Annual Meeting on September 22. <u>In this Starlite</u>, you will find both the current and proposed versions of Articles IV, V, VI and VII. These Articles are

presented in their entirety – not just the changes.

PAS BOARD MINUTES HIGHLIGHTS- (MAY-JULY)

May 16, 2012

The meeting was held at the Hardee's in Northpoint Shopping Center. The meeting was called to order by Rich Tennis. Minutes from the April meeting were reviewed. Bill Cole requested a minor change be made regarding the portable toilet at Northmoor. The modified minutes were then accepted. The Treasurer's report was presented for April. The Board accepted the presented report. Bill Cole reported Sheldon Schafer held a class at the observatory on the weekend prior to the official opening. Approximately 15 of Sheldon's students attended. Brian Hakes reported he has procured the materials for the plaque framing and plans to complete that work in the following weeks. Rich Tennis reported he has no updates on new posters for the warm up room. Nick Johnson reported he received two estimates for AV equipment and cabling from Advanced Audio. One estimate included an overhead projector and screen, while the second substituted a 46" flat screen monitor in the system. Both estimates were in the \$3000 range. Both estimates included equipment, cabling for both the warm up room and dome, a wall mounted input panel and labor. Nick pointed out that the estimate did not include a camera or splitter for the telescope, but did provided the cabling in the dome to support a scope-mounted camera if we decide to procure one. Eric Clifton reported that all 6 ICC spring star party dates were cancelled due to weather. He added that Brian Bill requested a summer ICC star party. Planning dates are July 13,14, 20 and 21st. Jesse Hoover reported the position of Public Relations is currently open and the position of Treasurer will become open in September. Mike Hay reported that he will begin writing the next Starlite during the week of May 20th. Jesse Hoover reported connectivity problems continue to occur sporadically with the website. Rich Tennis reported that Sheldon Schafer will meet with the new museum directors to determine arrangements for PAS use of the museum for public meeting starting this fall. Rich also reviewed the upcoming June 23 Northmoor rededication.

June 20, 2012

The meeting was held at the Hardee's at Northpoint. Minutes from the May meeting were reviewed. Brian Hakes and Bill Cole requested two minor changes. The modified minutes were accepted. Brian Hakes present the treasurer's report for May. The Board accepted the report as presented. Brian also reported he is in the process of contacting the Peoria Academy of Sciences in order to reconcile membership dues PAS owes. Bill Cole reported the June 16 public observation session was cancelled due to weather. He also reported that he was contacted by the Peoria Public Library regarding this year's "Observe the Moon Night". The library would like to co-sponsor the event coinciding with one of our regular Northmoor viewing sessions in September. Rich Tennis reported on the upcoming Northmoor Re-dedication event. Invitations have been sent to the Park Board, the Labor Union that performed the remodeling work and all organizations that contributed to the renovation. Bill Cole reported that both plaques are now mounted on the east wall of the warm up room. Eric Clifton reported that he and Perry White repaired the mower at Jubilee. He also reported that the 24' dome currently has a problem that prevents it from being opened. Jesse Hoover reported there are no current candidates for the Public Relations chair and the upcoming Treasurer vacancy in September. Scott Swords reported that there were three new members last month, Craig Rohlfs, Andy Barth and Jay Varadarajan. Jesse Hoover reported he will update the website with the Northmoor rededication recap and photos when they are available. Gary Bussman reported that 6 members have committed to bring telescopes to the next ICC star party at Jubilee. He also reported a recent occurrence where a new member had to wait outside the Jubilee gate until another member arrived. He recommended that the gate combination be given to all new members. In Unfinished business, Rich Tennis brought up the topic of the Memorandum of Understanding for use of the new museum for next year's general membership meetings. Eric Clifton made a motion that the current document be rejected as currently written. Scott Swords seconded the motion. In the ensuing discussion, Eric pointed out the ambiguity of statements relating to PAS assistance to the museum and what obligations that might hold. He would also like to see more recognition of PAS as co-hosts at museum events as well as public acknowledgment of PAS skills and capabilities in any publications regarding the proposed partnership. Eric offered to draft a revised memorandum. The Board then voted to approve Eric's motion and reject the current memorandum version and to table the topic until a revised document is completed.

BOARD MINUTES HIGHLIGHTS CONTINUED

July 18,2012

The meeting was held at Hardee's at Northpoint. Minutes from the June meeting were reviewed. Bill Cole noted one typographical error. The modified minutes were accepted.

Brian Hakes presented the Treasurer's report for June. The Board accepted the report as presented. Bill Cole reported that weather has been spotty during the last month's Saturday viewing sessions. Rich Tennis reported that the Central Illinois Community Assn. plans to visit Northmoor to see the renovation results. He expressed appreciation for the job the Peoria Park District performed. He recognized Brian Hakes for his great work in mounting the plaques and Dan Son for providing drinks at the event. Eric Clifton reported that the ICC star party is scheduled for the next weekend (July 20,21). He added that John Doolin, an instructor at Carol Sandberg Junior College plans to attend with 8 of his students. Eric also reported that he and Jesse Hoover inspected the malfunctioning 24" dome and found that the motor was not driving the dome. He suggested that Ash Domes be brought in to assess the situation and provide an estimate to bring the dome mechanics to a more "off the shelf" condition. Eric then made a motion that Ash Dome be contracted for an assessment. Calene Fleming seconded the motion. In the ensuing discussion, John Barra reminded the group that the Board had previously agreed that no improvements would be made to the 24" dome until the 14" dome was fully operational. Mike Hay added, that with both domes down, we need to stop talking and start spending to repair the PAS assets. Eric's amendment was modified to engage Ash Domes to address only the items required to make the 24" dome operational. The amendment also allows Ash Dome to make repairs in the event the dome can be fixed with materials Ash Dome has on had during the visit. Any other "improvement" items for the 24" dome will be deferred until the 14" dome is operational. The amended motion was passed. The board also reaffirmed their previous approval to engage a certified electrician to assess and repair the electrical feed to the 14" dome. Jesse Hoover reported he has no candidate for the Public Relations position. Scott Swords reported that there was one new member this month, John Pippis. Mike Hay reported that the Starlite will be published approximately 10 days after the Board meeting. John Barra reported that the "swap" meet planned for October has been cancelled and as a replacement program, the October meeting will be at Northmoor with the intent of reviewing the equipments and operations. Jesse Hoover reported that the constellation links on the website are now operational. Nick Johnson reported that per last month's meeting, he investigated any potential legal ramifications of sending member phone numbers and address to other PAS members. He found that current privacy laws do no prohibit such distribution unless specifically requested by a member.
